3.....	Lack of driving experience, plus additional lack of emotional maturity.
	<b>Non-Speed Related Moving Violations</b>
	Spilled load
1.....	Operating where prohibited
1.....	Improper turn
1.....	Failure to keep proper lane
1.....	Ran off road
1.....	Driving on road shoulder, in ditch, or on sidewalk
1.....	Making improper entrance to, or exit from, freeway
1.....	Starting improperly from a parked position
1.....	Improper backing
1.....	Failure to signal
1.....	Failure to yield right of way at sign
2.....	Failure to yield right of way to emergency or other authorized vehicle
2.....	Failure to follow instruction of police officer
2.....	Failure to yield right of way in manner required at unsigned intersection
2.....	Spilled load (solid object)
2.....	Failure to obey traffic instructions stated on traffic signs or shown by traffic control devices

0.....	Accident – <i>Not at Fault</i> , as indicated by police report
2.....	Accident with a fixed object
2.....	Accident – Ran off roadway
3.....	Accidents – All others
	<b><u>ALCOHOLIC, DRUGS, AND/OR RECKLESS DRIVING; OTHER MAJOR OFFENSES</u></b>
6.....	Reckless Driving is included because it is frequently a reduction from an alcohol or drug-related charge.
N/A	Other major offenses must be considered on an individual basis, but generally disqualify the driver.

### ***Non-Moving Violations***

Non-moving violations are not normally considered in evaluating the individual driver, unless they are excessive or indicate a lack of moral character.

### **Evaluation**

*New Personnel:* Any applicant with a score of seven (7) or more shall be denied.

*Annual Record Check:* Corrective action up to and including loss of driving privileges will be considered for any personnel with a score of five (5) or more.
